Mitsubishi Electric Named to CDP's Supplier Climate and Water A Lists

Receives four A-List recognitions for second consecutive year

TOKYO, January 11, 2018 – [Mitsubishi Electric Corporation](http://www.MitsubishiElectric.com) (TOKYO: 6503) announced today that the CDP, a global disclosure system that enables companies and cities to measure and manage their environmental impacts, has presented the company with top “A List” rankings for outstanding climate- and water-management practices that Mitsubishi Electric deploys in its supply chain programs. This is Mitsubishi Electric’s second consecutive year to be named to these leaders’ lists.

A-List rankings are based on questionnaires sent to suppliers in the supply chains of CDP member companies.

The CDP also announced in October 2017 that Mitsubishi Electric had been named to the separate CDP Climate 2017 A List and CDP Water 2017 A List, both for the second consecutive year, recognizing the company’s outstanding efforts to mitigate climate change and protect water resources, respectively.

Mitsubishi Electric is a leader in the development and provision of advanced environmental technologies that enable diverse global businesses to achieve enhanced sustainability, safety, reliability and comfort for the benefit of global society. Based on its Environmental Vision 2021, the company is contributing to the creation of low-carbon, recycling-based societies and biodiversity protection. Mitsubishi Electric is also contributing to sustainability by steadily reducing the environmental impact of production processes throughout its global value chains and by developing reduced-impact products and services.
